Release

I AM A MEMBER OF THE Keystone Rod and Gun Club ("Gun Club"), which has signed a Release and Indemnification Agreement with Keystone Cement Company ("Keystone") for the use of Keystone's property ("the Property") for hunting and fishing.

In consideration of the permission granted by Keystone to the Gun Club to enter the Property and use it for small game hunting and fishing, and to permit members to enter the Property for those purposes, I release and discharge Keystone and its officers, directors, agents and employees for all claims, liabilities, interest, attorneys' fees, demands, actions, and causes of action for property damage or personal injuries, including death, arising from or in any way related to my entry onto the Property, whether or not caused solely or in part by any act or omission of Keystone or its officers, directors, employees or agents, or caused solely or in part by any act or omission of Keystone or its officers, directors, employees or agents and myself, or caused solely or in part by the conditions of the Property.

I understand the dangers connected with hunting and fishing, and understand that unanticipated and unexpected dangers may arise. I assume all risks of entry onto the Property. I understand that Keystone has no duty of care towards the Gun Club or myself.

I have been instructed concerning safety practices in the use of the Property and I am aware of the boundaries of the Property on which I am permitted to hunt and fish. I have been fully warned and understand the dangers associated with blasting, mining, quarry and cement-making operations. I agree to obey all applicable laws, rules and regulations.

I will not use alcoholic beverages or other intoxicants while on the Property, nor will I enter the Property while under the influence of alcoholic beverages or other intoxicants. I will not give alcoholic beverages or any other intoxicants or make them available to any other member while on the Property.

I have not been charged a fee for the use of the Property.
